Compliance

The suppliers compliance must match our compliance.

Properties

A property is a feature of a subject. It is rated for its degree of fulfillment in a subject, where 0 is the least manifestation and 10 is the most. Properties are also rated against each other in order to get a ranking of the importance for the project. The following list represents all neccessary properties for this project's requirements with descriptions of the different degrees of fulfillment.


